Projects include replacement of gutters; upgrade of security cameras and replacement of outside concrete work.

Travel and Related Expense Reimbursement 2015-2016

BE IT FURTHER RESOLVED that Policy #6471 – School District Travel (Travel Policy) and NJAC 6A:23B-1.2(b) provides that the board of education shall establish a maximum expenditure that may be allotted for such travel and expense reimbursement including registration fees for professional development workshops and conferences and that for the 2015-2016 school year the maximum is \$10,000; and

BE IT FURTHER RESOLVED that the School Business Administrator shall track and record travel costs to insure that the maximum amount is not exceeded.

BE IT FURTHER RESOLVED that the Board wishes to "bank" the unused 2015-2016 allowable tax levy for use in a subsequent budget year in accordance with N.J.S.A. 18A:7F-39.
