Theresa Lewis from New Jersey School Boards Association presented the Educational Reform Initiatives as they pertain to our district. She discussed NCLB Waiver process, Common Core State Standards and the new EE4NJ.

Tenure Reform became law on August 6, 2012. Anyone hired after that dates will need four years and one day to obtain tenure. Teachers will be evaluated using a state approved evaluation system. The components of the Tenure Reform consist of new teachers requiring mentoring, the implementation of a School Improvement Panel, and individual professional development plans for teachers.

Ms. Lewis discussed the Regional Achievement Centers created by the DOE and their role in helping low performing school increase test scores.

Boards of Education will be required to develop performance goals. They should discuss test scores at monthly meetings. More information from the state will be forthcoming.

Mrs. Buchalter thanked Ms. Lewis for an informative workshop.
